Caswell Training School - Originally known as School for the Feeble-minded. Coon was instrumental in its establishment, Dec. 1910-Aug. 1911.

Catawba County, North Carolina - Copy of Zion Church Record, 1815-1851, Lutheran Church, in Folder 91.

Davie County, North Carolina - New Jerusalem Church Record, 1766-1874, in Rowan County, now Davie. Translation from the German. Volume 15.

Federal Childrens' Bureau - Coon was active in the campaign for its establishment, April 1910-Feb. 1912. He was secretary of the North Carolina Child Labor Committee at the time.

Johnston County, North Carolina - Typed manuscript, author unknown, on educational development in Johnston County prior to 1870, in folder 90. Also a course of study for 1901-02, in folder 25.

Lincoln County, North Carolina - A paper on Lincoln County folklore in 1830, by Coon, in folder 50. Correspondence with William L. Sherril on research in Lincoln County history, folders 76 and 78.

Mecklenburg County, North Carolina - Papers of members of the Harris family, Gilbert Cowles, and other residents of Mecklenburg County, collected by Coon, probably during the period when he lived in Charlotte and was engaged in historical research on the history of Mecklenburg. See survey of Folders 140-144 for more information.

National Child Labor Committee - Coon was secretary of the committee in North Carolina and an associate member of the national committee. Correspondence with officials guiding the southern campaign, April 1909-Feb. 1914: A. J. McKelway, Owen R. Lovejoy, Wiley H. Swift, John Porter Hollis.

North Carolina Child Labor Committee - Coon was secretary of the committee, 1906-16. Correspondence and newspaper clippings on the work of the committee, 1909-16.

North Carolina Teacher's Assembly - Coon was active in this organization, chairman of the Committee on the History of Education, member of the committees on Professional Ethics and on Legislation and president in 1911.

Rowan County, North Carolina - Information on Locke Township Schools, by Coon, in Folder 25. Vol. 15 - New Jerusalem Church Record, 1766-1874, in Rowan, later Davie, County. Translation from German. See also Salisbury.

Salisbury, North Carolina. Coon was superintendent of the Salisbury schools from 1899 to 1903. See folders 26, 27, 70, Vol. 7 for information on schools during his administration and for letters from Salisbury residents.

Southern Education Board - Coon was secretary and editor of the Bureau of Information and Investigation in 1903, with headquarters in Knoxville, Tenn. See folder 26 for his report on the work of the Bureau under his direction.

Pacifism and Peace Movements - Correspondence, Feb. 1914; Nov. 1915; Jan. 1920; Nov. 1921, with Claude Kitchin, about opposition to Woodrow Wilson's preparedness campaign. Coon organized Peace Day in 1912, 1913 for the American School Peace League and spoke at the organization of the N. C. Branch of the American Peace Society in 1913.

Religion - education - Lessons on various books of the Bible prepared by Coon in 1924 for the Methodist Episcopal Church of Wilson, N. C. Folder 119. (Coon himself was Lutheran.)

Religion - Lutheran Church - Coon was a member of the Lutheran Church and was interested in its history and in the history of its German membership. See folder 91 for copy of Record Book of Zion Church, Catawba County, 1815-1851; see Vol. 15 for translation from German of Record of New Jerusalem Church, 1766-1874, in Rowan, later Davie, County.

Writers and Writings - Material on historical research and writing scattered throughout, dealing with history of education in N. C., contributions and membership on editorial board of North Carolina Historical Review, correspondence with N. C. historians, especially R. D. W. Connor, interest in local, state history, the Germans in North Carolina, history textbooks.

Writers and writings - historical - Wrote for North Carolina Historical Review, and served on editorial board, corresponded with R. D. W. Connor and other N. C. historians, was interested in history of education, of German settlers in N. C., other aspects of state and local history and history textbooks, edited documents on educational history. There is material reflecting these interests scattered through the papers.
